



#### SUMMARY OF DELIVERING PRACTICAL TRAINING (CLINICAL AND LABORATORY) TO THE STUDENTS







The current setup limits the development of skills and competencies of DVM students that are necessary for them to learn before graduating.



IMPACT OF COVID-19: To determine the impact of COVID-19 in providing the quality veterinary education in AAVS Members two years after the emergence of COVID-19.


#### DID YOUR INSTITUTION CONDUCT COVID-19 VACCINATION PROGRAM FOR STAFF AND STUDENTS?


84% uses online teaching/learning (e.g., conduct of seminar).

40% invites guest lecturers for special topics.


12% did not experience "learning/ teaching" loss.




- Most of the students had IT devices ready for online learning but internet accessibility and stability were major concerns.






