## VetEd ASIA 2026 – Veterinary Education Research Session

**24th AAVS Annual Meeting, Tokyo, Japan  
22 & 24 April 2026**

The 24th AAVS Annual Meeting will be held in Tokyo, Japan, in conjunction with the [41<sup>st</sup> World Veterinary Association Congress](#) to be held from 21<sup>st</sup>-24<sup>th</sup> April 2026 in Tokyo.

The AAVS working group on Veterinary Education Research (VER-WG) will be hosting [a Veterinary Education Research Session](#). The event will comprise of original Veterinary Education Research findings, and this Call for Abstract is open to all faculty members of AAVS Member institutions. This year, we may also accept a limited number of abstracts from non-Member schools. The session will be held in a hybrid format.

With this background, we invite you to submit Abstracts based on original Veterinary Education research. We invite original research findings from diverse research areas such as, but not limited to:

- Student retention and progression
- Assessment, feedback and learning
- Teaching effectiveness
- Student learning
- Faculty development
- Professional identity
- Clinical skills learning and assessment
- Communication skills learning and assessment
- Diversity, equity, inclusion and belonging

All submissions will be subjected to a peer review process. For accepted submission, the first/corresponding author will be invited to give presentation physically or virtually during the

annual meeting or share a recorded presentation of their work (and be available virtually during the session).

### **Guidelines for Authors:**

1. Formatting: Times New Roman size 12, single space, normal margins (1"), left justified
2. Title: Maximum 20 words, no abbreviation, bold
3. Authorship:
  - a. Individual author: First name, middle initial, last name (e.g. Sandy J Brookes)
  - b. Multiple authors: Names of authors separated by a coma (Sandy J Brookes, Ahmad Nijad)
  - c. Affiliation of each author identified through alphabetical superscript, and provided in italics in the line/s below the authors' names. E.g.  
Sandy J Brookes<sup>a</sup>  
*<sup>a</sup>Department of Physiology, College of Veterinary Science, University of Turin, Italy.*
  - d. Corresponding author should be identified with a \*. E.g. Sandy J Brookes<sup>a\*</sup>
4. Abstract: Without internal headings, maximum word count 300 words. The abstract is expected to include information on background, methodology (information on subjects, statistical design, analysis etc.), results and discussion, conclusion.
5. References: Citation style recommended by Journal of Veterinary Medical Education.
